

Citrus County Historical Society Annual Awards

Nominations must be received by August 1, 2020 to be considered.

Mary I. MacRae Decade of Service Award (est. 1989):

Recognizes an individual member who has distinguished himself/herself by the quality and duration of their commitment to the field of Citrus County History. Must have 10 years of CCHS membership.

Distinguished Service Award (est. 1993):

Must have at least 5 years of outstanding service. Recognizes an individual member who has demonstrated quality and duration with a distinguished commitment to the field of Citrus County History.

Education Award (est. 1989):

Recognizes an individual or organization for a new and outstanding education exhibition, program or event. (Recognizes an individual, group, organization, agency, or business who has furthered the knowledge of the history of Citrus County by design of an educational tool for the public and has increased the public understanding, awareness and/or appreciation for the rich history of Citrus County.)

Historic Preservation Award (est. 1989):

Recognizes an individual, group, organization, agency, or business who has significantly contributed to the field of Historic Preservation through physical restoration or conservation, financial support, advocacy, or education.

Media Award (est. 1989):

Recognizes an individual or organization in the field of media, public relations for an outstanding media product or service. (Recognizes an individual, group, organization, agency, or business who has made a significant contribution to the pool of compiled history by investigation, inquiry, fact-finding, examination and/or compilation of a significant segment of Citrus County's history (e.g. may be in form of interview, audio, video, or archival research).)

Heritage Museum Award (est. 2016)

Recognizes an individual, organization, agency, group or business who have substantially contributed to the education of the public by contributions of research for the design of and or creation of a museum exhibit or for support services that enhance or further the education of the public (e.g. docent)

Artifact/Archival Conservation Award (est. 2013)

Recognizes an individual, group, organization, agency, or business who has made a significant contribution to preserving a portion of the **tangible history** (except built environment) of Citrus County. Includes but is not limited to the recovery, collection, and or donation of artifacts and or archival materials that have a direct bearing on or connection to the history of Citrus County.

Individual Heritage Council Awards (est. 2006)

Recognizes a member or members within each of the five Heritage Council who has demonstrated distinguished service to that Council during the past year. Members shall have demonstrated an exceptional level of volunteerism in a single or in various activities for the benefit of that Council.

CCHS President's Award (est. 1989) (selected by the President of CCHS)

Recognizes, annually, a member or members who throughout the year have given outstanding support/service beyond the normal requirements of whatever position or role they may have held.
